**NOTES:**

- Protection for stands of trees and individual trees and their root zones to be preserved and such protection extends at least to the drip line.
- Public trees that are removed or damaged during construction shall be replaced with equivalent.
- New plant material to be located in the field by the landscape architect or designated representative of the Housing Board.
- Substitutions to be approved by the landscaping architect.
- Owner must maintain the buffer as depicted in landscape plan
- Rain gardens to be over seeded with New England erosion control/ restoration mix for detention basins and moist sites at the rate of 1.25lbs/ 1250sf. Supplier New England wetland plants, Inc. www.newp.com
